

# State Unemployment Rate at 6.6 Percent

West Virginia's seasonally adjusted unemployment rate increased three-tenth of a percentage point to 6.6 percent in August 2014. The number of unemployed state residents rose 1,900 to 52,400. Total unemployment was up 1,000 over the year. The national unemployment rate decreased one-tenth of a percentage point to 6.1 percent.

Total nonfarm payroll employment decreased 100 in August, with losses of 200 in the goods-producing sector and a gain of 300 in the service-providing sector.

Within the goods-producing sector, employment gains included 200 in mining and logging; declines included 100 in construction, and 300 in manufacturing. Within the service-providing sector, employment declines included 700 leisure and hospitality 700 in government, 400 in other services, 300 in trade, transportation, and utilities and 200 in financial activities,. Employment gains included 1,100 professional and business services, 1,300 in educational and health services, 200 in information.

Since August 2013, total nonfarm payroll employment has risen by 8,200, with a gain of 8,400 in the service-providing sector easily offsetting a decline of 200 in the goods-producing sector. Employment gains included 5,700 in professional and business services, 3,200 in leisure and hospitality, 1,700 in financial activities, 1,400 in mining and logging, 200 in manufacturing, 1,400 in educational and health services, 300 in information, Employment declines included 3,400 in government, 1,800 in construction, 400 in trade, transportation, and utilities and 100 in other services.

West Virginia's not seasonally adjusted unemployment rate increased five-tenths of a percentage point to 6.6 percent.



# WEST VIRGINIA DATA COUNTY EMPHASIS



West Virginia's seasonally adjusted unemployment rate increased one-tenth of a percentage point to 6.3 percent in July 2014. Unemployment rates increased in 42 counties, decreased in ten counties, and were unchanged in three counties. Counties with employment rates above 10 percent included McDowell (10.2), Logan (10.2), Wetzel (10.6), and Mingo (12.1). Counties with an unemployment rate at or below 5.0 percent included Harrison (5.0), Putnam (4.8), Lewis (4.7), Pendleton (4.5), Jefferson (4.4), and Monongalia (4.1).
